The Times Higher Education Impact Rankings, which assesses the contribution of universities around the world to sustainable development goals, has been an important source of motivation for us to see our place in the world and measure our contribution with all the activities we carry out for sustainable development as a higher education institution. As Istanbul Medeniyet University, we were included in THE Impact Ranking for the first time in 2021 by applying with only 4 SDGs, while we applied with 11 SDGs for 2024, being ranked 601-800 in the global ranking. 16 PEACE, JUSTICE AND STRONG INSTITUTIONS



Without peace, stability, human rights and effective governance, based on the rule of law - we cannot hope for sustainable development. We are living in a world that is increasingly divided. Some regions enjoy sustained levels of peace, security and prosperity, while others fall into seemingly endless cycles of conflict and violence. This is by no means inevitable and must be addressed.

High levels of armed violence and insecurity have a destructive impact on a country's development, affecting economic growth and often resulting in long standing grievances

that can last for generations. Sexual violence, crime, exploitation and torture are also prevalent where there is conflict or no rule of law, and countries must take measures to protect those who are most at risk.

The SDGs aim to significantly reduce all forms of violence, and work with governments and communities to find lasting solutions to conflict and insecurity. Strengthening the rule of law and promoting human rights is key to this process, as is reducing the flow of illicit arms and strengthening the participation of developing countries in the institutions of global governance.



## **OPERATIONS**

#### Students' Union

IMU has an independent student council. The aims of IMU Students' Council are to ensure that the students registered in our university contribute to the development of the university; to convey the students' views and suggestions to the necessary units on meeting and developing their education, health, sports and cultural needs and to be a solution partner in these matters; to ensure that the students participate in the management in education issues; and to ensure that students are sensitive to national interests and are represented at non-university institutions when necessary. The Council consists of the student representatives elected community. student by the Student representative elections are held in November every year.

## Identifying and Engagement with Local Stakeholders

Istanbul Medeniyet University has written policies and procedures to engage with its and external stakeholders. stakeholder groups have been clearly defined in our Institutional Strategic Plan for 2020-2024. We plan our services and activities by identifying the expectations of our internal and external stakeholders through stakeholder satisfaction meetings, brainstorming, surveys and satisfaction surveys for the staff and students, and our system for submitting suggestions and expressing satisfaction.

We inform our external stakeholders about the University's activities and applications through the "Announcements" menu on our website. And we send our **external stakeholder surveys** online to receive the opinions and expectations of our large groups of external stakeholders in order to better analyze the University's current standing and projections for the future. IMU's procedures for managing stakeholder engagement are clearly explained in our **Internal Evaluation Report** published annually.

IMU's local stakeholders include regional directorates of central government agencies, the Governorship of Istanbul, local schools and universities, local government agencies, local industrial firms, trade union and civil government representatives, and local residents among others. Our stakeholders are regularly invited to have meetings with our governing bodies to participate in our decision making processes.

## University Principles on Corruption and Bribery

As a public institution, IMU is completely against corruption and bribery and complies with the Law No 3628 on Declaration of Property and Fight against Bribery and Anticorruption, which lays down rules for fighting with bribe and corruption, regulates the declaration of property by civil servants, renewal of declarations, supervision of acquisition of property, provisions applicable in case of unjust acquisition of property and false declaration.

## OPERATIONS

This law also regulates follow up and trial procedure for public officials and accomplices due to crimes specified in this law. As civil servants, all our staff members are obligated to comply with the provisions of the above law and the Regulation on the Declaration of Property and are to declare any property they have acquired at the start of their public service and renew their declarations when-ever they acquire a new valuable property. The declarations are made to our Personnel Department using the relevant form on the web page.

#### **Academic Freedom Policy**

In Article 27 of the Constitution of the Republic of Turkey, it is stated that everyone has the right to study and teach, express, and disseminate science and the arts, and to carry out research in these fields freely. Istanbul Medeniyet University supports this freedom in all aspects.

In addition, Turkey is a party to the International Covenant on Economic, Social and Cultural Rights. According to **Article 15** of this Covenant, The States Parties to the present Covenant recognize the right of everyone: to take part in cultural life; to enjoy the benefits of scientific progress and its applications and to benefit from the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he/she is the author. Our university also supports this Covenant.

#### **Publishing Financial Data**

The University's **Institutional Financial Status** and Expectations Report, which is annually published by IMU Strategy Development Department, contains the realization data on the University's budget for the first six months of the relevant year and the expectations and predictions for the second half of the year. The report also contains the data on the University's financing budget and revenues expenditures for the two periods, as well as detailed information about its major investment projects.

#### **Providing Expert Advice to Government**

Many of our faculty members contribute to decision- and policy-making at local, national, and international levels by providing expert government agencies advice and organizations through policy guidance and membership or chairmanship of various boards, commissions, and committees. Listed below are only a small part of our faculty members' contributions.

## Policy and Lawmakers Outreach and Education

**Havran Municipality** and IMU signed a collaboration protocol for ensuring that the municipality staff processes and transfers personal data in accordance with the Law on the Protection of Personal Data, raising awareness about the confidentiality of personal information and related security measures.

**Sultanbeyli Municipality** and IMU signed a collaboration protocol in education, application, and research aiming to use our university's academic expertise to enhance the municipality's service quality.

**Üsküdar Provincial Directorate of National Education** and IMU signed a protocol for collaboration in education concerning improving the quality of education services in the educational institutions run by the Directorate, developing programs to enhance student success, and conducting services to increase teachers' competencies.

**Kartal Provincial Directorate of National Education** and IMU signed a protocol on cooperation between academic staff, administrators, teachers, students in the fields of education, training, research and development.

IMU signed a protocol with the **Turkish Statistical Institute** on cooperation in academic, scientific and educational fields, project studies, consultancy services, seminars, conferences, etc. in the determined fields.


Istanbul Anatolian Chief Public Prosecutor's Office Probation Directorate signed a collaboration protocol with IMU in "education. research, consultancy and project design" fields. Within the scope of the protocol, IMU will contribute to the academic support of the staff working in judicial services and increase their professional competence, to provide within budget convenience the and administrative possibilities, to the Chief Public Prosecutor's Office and directorate staff who apply to the non-thesis Master's programs, organizing educational, social, cultural, and sports activities aiming to increase the productivity motivation and among the institution's staff, support the reintegration of those under probation measure into society and to develop social responsibility projects for individuals in this group to ensure that the convicts can make the best use of their time in the institution by acquiring the knowledge and skills required for their social rehabilitation. Thanks to this protocol, IMU contributed to justice system with its components and also contributed to creating a peaceful society.



## LEARNING



Learning processes are key in achieving SDGs. Thus, universities play a critical role both by training professionals who will prioritize SDGs in their future practices and by increasing local, national, and global capacity to successfully achieve SDGs. As Istanbul Medeniyet University, we are aware of our critical role and therefore, we primarily inform our students, the leaders and decision-makers of the future, about the Sustainable Development Goals through course contents, co-curricular activities and student club activities and strengthen their awareness. For this purpose, each of our faculties and departments prepares SDG-related course contents, including courses that address the Sustainable Development Goals holistically, as well as specific contributions that can be made by the expertise of the relevant professional field in which they provide training. In 2024, 25 courses related to SDG-16 were given at IMU. Some of these are listed below.

## EVENTS

On April 30, 2024, Istanbul Medeniyet University hosted a high-profile panel titled <u>"Civil Constitution in the 100th Year of the Republic"</u>. The event offered a platform for critical reflection on constitutional reform, institutional legitimacy, and civic participation.

Panelists argued that Turkey's current constitutional framework requires a more dynamic and participatory overhaul. It was emphasized that any constitution should not only include liberal-democratic principles, but must also be drafted through a pluralistic, inclusive, and participatory process.

Speakers emphasized the critical importance of civil society engagement in shaping the constitution. They pointed out how non-governmental organizations, professional associations, and citizen groups can act as vital counterweights to dominant political powers, contributing to checks and balances.

The panel also addressed the concept of vesayet (guardianship) in constitutional formation—

exploring how power imbalances can undermine meaningful participation and erode institutional trust.

There was a strong focus on the historical evolution of constitutional arrangements in Turkey. The discussion traced how constitutional design has reflected political struggles, governance models, and shifting understandings of legitimacy. By situating the debate in a historical context, panelists underlined the urgent need for institutional reform that aligns with modern democratic standards and ensures stronger rule-of-law protections.

In its framing, the event directly addressed promoting inclusive institutions (16.6), ensuring public access to justice (16.3), and strengthening participatory decision-making (16.7). By calling for a citizen-centered and legally sound constitutional framework, the panel contributed to ongoing debates about how Turkey can build more resilient, accountable, and democratic institutions.





"Civil Constitution in the 100<sup>th</sup> Year of the Republic" Panel

#### EVENTS

The Human Rights Research and Application Center at Istanbul Medeniyet University held a **mock court session** focusing on rule of law, access to justice, and accountability for human rights violations. The session, conducted on 8 May 2024, examined Israel's actions in Gaza over the past seven months on the basis of South Africa's genocide case submitted to the International Court of Justice.

A panel of academic judges oversaw the proceedings, while students represented the opposing sides and engaged directly with procedures such as evidence presentation, legal reasoning, and the right to defense. Claims regarding attacks on civilians, obstruction of essential humanitarian resources, and mass killings were evaluated within the framework of international criminal law and the potential elements of genocide. The defense rejected all allegations, framing Israel's actions as security-driven.

The first session included testimony from two Palestinian witnesses from Gaza and the West Bank, offering insight into the humanitarian impact of the conflict. Through this exercise, participants were able to observe how international justice mechanisms function and explore how legal processes contribute to strengthening institutions, upholding human rights, and promoting peaceful and just societies.

The second session of its mock court on May 15, 2024. The session focused on Israel's actions in Gaza from the perspectives of international law, human rights, and accountability.

The court panel evaluated the claims presented by students representing both sides and heard testimonies from witnesses from Gaza. Students representing South Africa argued that Israel's civilians could constitute actions against genocide under international law. After reviewing the defenses of both parties, the court panel issued its decision within the framework of relevant international law. Participants also alleged discussed attacks on civilians. obstruction of essential resources, and mass killings, applying a legal perspective. This allowed students to directly observe how justice and the protection of human rights operate in practice.

The session not only provided an educational experience in legal procedures but also fostered awareness of accountability, transparency, and the strengthening of peaceful conflict resolution mechanisms, encouraging active participation of young people in justice-related processes.



## EVENTS

The "3rd International Information and **Technology Law Symposium"** organized jointly by Istanbul Medeniyet University and the Information and Technology Law Association on 29-30 November 2024, was held at the Âşık Paşa Conference Hall on the University's South Campus. Bringing together leading experts, practitioners, and academics, the symposium addressed critical contemporary issues such as legal regulation in a digitalizing world, cybersecurity, artificial intelligence law, crypto assets, and digital addiction—all of which remain central to strengthening institutional capacity supporting secure and just and digital governance. The symposium was open to public.

In th first speech, the impact of digitalization on national infrastructure was evaluated and that infrastructure security as a key component of national security was emphasized. Also the necessity of improving cyber resilience, reinforcing institutional safeguards, and ensuring accountability in digital systems was underlined.

In the second and third speech it was mentioned the rapid rise in internet usage and e-commerce volume, drawing attention to the risks associated with cybersecurity. The importance of transparent regulation, coordinated governance, and robust justice systems to protect public rights in an increasingly digital environment was highlighted.

Our Rector, Prof. Dr. Gülfettin Çelik, pointed out that achieving regularity, continuity, and predictability in national and international digital governance has become increasingly difficult. He stated that a country must strengthen its institutional capacity, develop globally aligned legal frameworks, and contribute to the rule of law in digital spaces. Çelik also linked academic work to the wider goal of promoting justice, ethical governance, and resilient legal institutions in his speech.

The symposium hosted sessions on a wide range of topics, including commercial law in the context of digital transformation, artificial intelligence law, fintech, data law, and intellectual property, all of which influence the development of transparent, fair, and accountable legal frameworks.

Concluding with high participation, the symposium provided new perspectives on building strong institutions, ensuring responsible digital governance, and advancing the goals by promoting justice, the rule of law, and inclusive, effective, and accountable institutions in the digital age.



## EVENT:

A seminar titled "Divorce and Property Regime Settlement in Practice" organized by the Ideal Medeniyet Law Club as part of its event series "Fragment of the Profession," was held on December 10, 2024, at the Bankkart Hall of the Ziraat Bank Library at Istanbul Medeniyet University. Attorney Fatih Karamercan and attorney and mediator Neriman Uygur participated as speakers and shared their expertise with students.

The seminar offered comprehensive insights into divorce cases, legal rights in divorce, the structure and principles of property liquidation, principle of fault, expert the witness involvement, and mediation processes within the broader scope of family law. By addressing the practical challenges faced during the divorce process and presenting international examples, the speakers contributed to strengthening students' understanding of fair legal procedures, access to justice, and transparent decisionmaking mechanisms.

"Divorce and Property
Regime Settlement in Practice" Seminar

Organized by the Aydın Medeniyetliler Academy Student Club, the panel titled "Artificial Intelligence Law" brought together law and technology perspectives at Istanbul Medeniyet University on December 19, 2024, at the Central Library Bankkart Hall. The event examined how artificial intelligence (AI) is reshaping legal processes and explored its implications for ethical governance, human rights, and strong institutions.

The panel addressed questions such as "Can artificial intelligence make judicial decisions?", prompting discussions on the extent to which advanced technologies can be integrated into judicial systems without compromising the rule of law, judicial impartiality, or procedural fairness. Speakers evaluated the possibility of using Al as a supportive tool in criminal courts, focusing on how digital systems could enhance efficiency, transparency, and accountability in judicial processes. The panel also examined how digital transformation is reshaping the legal landscape broadly. including more the emergence of digital rights.
